

## KEY INFORMATION DOCUMENT

### Purpose

This document provides you with key information about **Mobeus Income & Growth 4 VCT plc**. It is not marketing material. The information is required by law to help you understand the nature, risks, costs and potential gains and losses of this product and to help you compare it with other products. This document is prepared on the basis that an investor is either subscribing for new shares in the Company via an offer for subscription ("Offer") or purchasing secondary shares on the London Stock Exchange ("Secondary Market Purchase").

### Product

**PRIP Manufacturer:** Mobeus Income & Growth 4 VCT plc ("Company") is incorporated and registered in England and Wales as a public company limited by shares under the Companies Act 1985 with registered number 03707697.

**You are about to purchase a product that is not simple and may be difficult to understand**

### What is this product?

The Company is a venture capital trust ("VCT") with one class of ordinary shares of 1p each which are listed on the London Stock Exchange. The Company's shares are typically subscribed for via an Offer which, for eligible VCT investors, will attract income tax relief on the amount subscribed, as well as other VCT tax benefits. Existing shares can also be bought and sold via a Secondary Market Purchase. The purchaser of such shares does not benefit from the initial upfront income tax relief, but may still benefit from the other VCT tax reliefs. Shares typically trade on the stock market with a bid-offer spread such that, at any point in time, the price that you can buy them for (offer price) will be more than you can sell them for (bid price).

The objective of the Company is to provide investors with a regular income stream, by way of tax-free dividends generated from income and capital returns, while continuing, at all times, to qualify as a VCT. The life of the Company may be periodically voted on by shareholders, although the Company's shares do not have a specified maturity date or unilateral termination date.

The Company's policy is to invest primarily in a diverse portfolio of young unquoted UK companies for the purpose of their growth and development. Investments are made in companies that are deemed qualifying in accordance with HM Revenue & Customs ("HMRC") requirements and are typically made alongside the other VCTs advised and managed by Gresham. The Company aims to pay returns to shareholders by way of dividends (tax-free for eligible VCT investors) which primarily arise from a) income generated from the investments it holds, and b) capital gains arising from profitable investment disposals.

By focusing on VCT-qualifying companies, the Company intends to maintain its status as a VCT thereby enabling investors to benefit from connected tax advantages. The value of the Company's shares, and returns received thereon, will depend on the performance of the investments selected.

If investing via an Offer, in order to benefit from 30% initial income tax relief, investors are required to hold the investment for a minimum of five years. If the investor were to sell before this date any initial income tax relief will be repayable to HMRC. A typical retail investor for this product would be a relatively high net worth individual, who already owns a quoted investment portfolio, and wishes to allocate funds to a relatively higher risk product as part of a balanced portfolio. They will be able to utilise the tax advantages of the product and could afford to withstand any losses that may arise from an investment in a VCT

### What are the risks and what could I get in return?

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because you are not able to realise any value from your shares.

You may get back less than the amount invested. You may not be able to sell your shares easily or you may have to sell at a price that is significantly less than you anticipated or significantly impacts on the total return achieved. Although the Company has a share buyback policy (see 'How do I sell my shares?' below), the shares of the Company are otherwise relatively illiquid and it may be difficult to return value to shareholders if a substantial number of shareholders all want to sell at the same time.

We have classified this product as 6 out of 7, which is the second highest risk class. This is considerably higher than the risk rating shown in the previous KID which arises from a change in methodology such that all VCTs must now have a minimum risk score of 6.

The Company's investments are in unquoted entities which have valuation and performance uncertainties and liquidity risk. Other relevant risks: Economic, VCT Conditions, Regulatory, Financial, Market, Market Liquidity, Counterparty. With higher risk comes also the potential for higher returns: see 'Performance Information' below for more details of past and prospective possible returns.

The value and tax benefits are conditional on the shares being held for at least five years and the Company maintaining VCT status.

**Performance Information**

The main factors that will affect the performance of the Company are the performance of the young unquoted companies held within the portfolio; the ability of the Investment Adviser to; a) identify suitable investments for Board approval; b) realise portfolio companies profitably; and c) the ability of the Board to oversee the Company and its objectives. Investors should note that c.25% of the portfolio is made up of investments made under the previous management buyout (“MBO”) strategy which, since November 2015 is no longer permitted. Since this date, all new investments must be in smaller, younger companies that carry higher risk, albeit the prospect of higher but more volatile returns. All performance data is based upon share price total return, which assumes that dividends are reinvested at the date of payment.

The Company has delivered a share price return of 15.8% with a volatility of 13.7% over the past five years to 26<sup>th</sup> September 2022 on an annualised basis. Since inception in March 1999, the average rolling five-year return was 3.6% per annum.

Our central projection of possible future returns is 14.6% per annum over the five-year recommended holding period. We have used the ex-ante return to model the reduction in yield in our cost calculations below.

Venture Capital Trusts can carry more risk than might be indicated by the Company’s share price performance history, so we have also compared the Company against a liquid daily traded investment proxy in the narrative below.

The proxy used for this Company is a blended benchmark of equity indices to reflect the Company's sector asset allocation on 31 December 2021. These sectors were reweighted based on available data to provide a full performance history over a sample long-term period from 1 January 1999 to 26 September 2022.

The volatility of the Company’s returns will vary from the average, the highest volatility calculated over a rolling five-year period was 53.2%, for comparison the highest five-year risk observed in the proxy is 22.9%.

**What could affect my return positively?**

Specific factors that could affect returns positively would be value growth and income returns in and from the Company’s portfolio, alongside making profitable realisations. Income and capital returns will support the Company’s dividend policy. General factors that affect positive returns for the VCT would be an extended period of UK economic growth and fiscal stability. Increased in the software and computer services and the UK Retailers sector indices will likely benefit returns as these sectors make up around 75% of the holdings within the portfolio. Day to day, the Company’s correlations to UK markets is quite low but we would also expect to see improvements in valuations in the UK equity markets to correlate with improvements in valuations in the underlying holdings, particularly during larger upward market movements.

In terms of quantitative evidence, the highest one-year return for the Company was 75.3%. Over the recommended holding period of five years, the highest five-year rolling performance of the Company was 19.4% per annum, similarly the best rolling five-year return of the proxy was 25.1% per annum.

**What could affect my return negatively?**

Specific factors that affect returns negatively are an underperforming portfolio of unquoted companies, with some companies potentially being realised at a loss, a lack of income and capital returns impacting dividend payments to shareholders and a lack of cash liquidity to pursue new and follow on investments. Other factors that are likely to affect returns negatively would be poor performance of the UK equity market, in addition a decrease in the software & computer services and retailers’ sector indices, is likely to negatively impact on returns.

In terms of quantitative evidence, the lowest one-year return for the Company was -46.4%. The lowest five-year rolling return for the Company was -26.18% per annum, and for comparison the proxy’s lowest five-year return was -11.3% per annum.

**What could happen under severely adverse market conditions?**

A severe experience could be a loss of -80.8%, which occurred in the Company from February 2001 to December 2008, it took over ten years for the Company to recover in July 2021. We identified a less severe loss in the proxy of -67.9% which occurred between March 2001 and April 2003. It took around nine and a half years to recover in September 2012. The Company may experience a high proportion of realised losses within the portfolio during periods of stress, which could result in you losing all of your investment.

**What happens if Mobeus Income & Growth VCT plc is unable to pay out?**

If the Company is unable to pay out, you might lose all of your investment. As a shareholder of the Company, you would not be able to make a claim to the Financial Services Compensation Scheme about the Company in the event that you lose money on your shares in the Company.

**What are the costs?**

The reduction in yield (“RIY”) shows what impact the total costs you pay will have on the investment return that you might get. The total costs take into account one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the product itself for three different holding periods. The figures assume that you invest £10,000. The figures are estimates and may change in the future.

The person selling you or advising you about this product may charge you other costs. If so, this person will provide you with information about these costs, as well as other costs such as any applicable taxes, and show you the impact that all such costs will have on your investment over time.

<sup>^</sup> - Gresham is entitled to 20% of the excess of dividends paid to shareholders over a target rate subject to the VCT's average Net Asset Value ("NAV") for the year exceeding the average Base NAV for the year. No fee was paid for 2019, 2020, and 2021.

#### How long should I hold it and can I take money out early?

This is a long term investment. If you invest via an Offer, you should be prepared to hold your shares for a minimum of five years. If you decide to sell your shares before then, you will be required to repay to HMRC the 30% upfront income tax relief you claimed.

#### How do I sell my shares?

VCT share prices are quoted on the London Stock Exchange, so you can buy or sell shares through a stockbroker or a share dealing account. It is worth noting that, since previously owned VCT shares do not qualify for the 30% upfront income tax relief, the market for buying second-hand VCT shares is limited. The open market price may therefore not reflect the underlying net asset value of the shares. The Company aims to offer a 'share buyback facility' for investors, provided that the Company has funds and reserves available. This facility allows existing investors in the Company to sell their shares back to the Company at a discount to NAV. The current policy agreed by the Board is to aim to buy shares back at a 5% discount to their NAV. Share buybacks are conducted at the Board's discretion, and therefore there can be no guarantees you will always be able to sell shares on request. Due to regulations governing public companies, there are restrictions as to when the Company may conduct a share buyback – for example, during a period when the Company is preparing its annual and half-year report and accounts.

#### How can I complain?

As a shareholder in the Company, you do not have the right to complain to the Financial Ombudsman Service (FOS) about the management of the Company.
